5.1. Principal –

- Addressing Media program and rumours going around community, cannot speak for the Board, they have their own argument(s) involved in this;
- Collective agreements have been renewed – provincial a few yrs ago – agreement local this year has changed (teachers etc.) categories have been basic school regulations; how many classes, hours of class that can be taught etc etc (instruction manual to deliver our courses);
- Media is not a course that can be offered in the BSR (nobody is qualified to teach this course – created friction between board and union), Board must respect collective agreement with the Board;
- Plan – must be discussed still with teachers: integrate media within the homerooms (will be divided within the minute of each course, teachers will be given minutes that will be specific to media, and then something must be removed;
- Many unanswered questions on how it will be integrated;
- In terms of media it will be still taking place;
- BSR -collective agreement; Category 107b no longer exists;
- Can ask for the PPP;
- PPP – school can apply for a special mandate for an addition course (e.g. sports etudes, arts etudes etc.);
- Will communicate once all details are known;
- Governing board can help parents – governing board members should bring this up at next meeting, must be launched through governing board;
- PPP – would, if passes, in the 2027-2028 school year;
- All this talk about media program was brought up end of April;
- Will try to find the best solutions to make it work;
- BSR is done by government.
