6.6 Appointment of Substitute Student Ombudsman

WHEREAS in accordance with section 220.2 of the *Education Act*, the Student Ombudsman is designated after consultation with the parents' Committee and on the recommendation of the Governance and Ethics committee;

WHEREAS section 4.6 of the proposed By-Law no. 8 – Complaint Examination Procedure, provides that the Council of Commissioners shall designate an individual to act as Substitute Student Ombudsman, to take over the role of Student Ombudsman during the period when the Student Ombudsman is absent and he cannot carry out his normal functions;

WHEREAS the English Montreal School Board (EMSB) approved resolution #20-09-22-7 to consult the *EMSB Parents' Committee* (EMSBPC) regarding the appointment of the recommended candidate for the position of Substitute Student Ombudsman;

WHEREAS the consultation period ended on October 23, 2020;

WHEREAS the EMSB Parents' Committee approved the appointment of the recommended candidate on October 20, 2020;

7. <u>Decision of the Substitute Ethics Commissioner : Angela Mancini, Chairman vs. Me Giuseppe Ortona, Interim Chairman</u>

WHEREAS Me Anthony Battah, the English Montreal School Board (EMSB) Substitute Ethics Commissioner, has rendered his decision on October 13, 2020, regarding the Angela Mancini, Chairman vs. Me Giuseppe Ortona, Interim Chairman complaint case filed on March 4, 2019;

WHEREAS the mandate of the Ethics Commissioner and its Substitute is to apply the Code of Ethics and Professional Conduct for Members of the Council of Commissioners of the EMSB (hereinafter the "Code of Ethics") and to provide for sanctions in accordance with the *Education Act*;

WHEREAS the Substitute Ethics Commissioner acquitted Me Giuseppe Ortona of alleged offences with regards to allegation #1 and allegation #2, and concluded in accordance with section 7.4.3 of the *Code of Ethics*, that Me Giuseppe Ortona discharged his duties in good faith with respect to these allegations;

WHEREAS section 7.4.4 of the *Code of Ethics* provides that all decisions rendered by the Ethics Commissioner are public, and shall be recorded in the minutes of the Council of Commissioners;

IT WAS MOVED BY THE TRUSTEE, MS. M. JENNINGS, AND RESOLVED THAT the Board acknowledges and deposits the decision rendered on October 13, 2020 by Me Anthony Battah, Substitute Ethics Commissioner in the case of Angela Mancini, Chairman vs. Me Giuseppe Ortona, Interim Chairman.

8. F.A.C.E Protocol for 2020-2021

WHEREAS the English Montreal School Board (EMSB) and the Centre de services scolaire de Montréal (CSSDM) jointly and collaboratively operate FACE (Fine Arts Core Education) School;

WHEREAS FACE School offers artistic diversified instruction to French and English-speaking students from the EMSB and the CSSDM;

WHEREAS since 1998 an Agreement identifies the obligations and responsibilities of the EMSB and the CSSDM in order to ensure the continuation of the educational project of FACE School;

WHEREAS by virtue of Resolution #20-08-12-4.6, an EMSB Governing Board was constituted for the school year 2020-2021 and an EMSB Principal was appointed at FACE School;

WHEREAS the Agreement in force between the Parties had to be revised to reflect these changes;

WHEREAS the Parties have agreed on the terms and conditions of an Agreement for the duration of the school year 2020-2021;

IT WAS MOVED BY THE TRUSTEE, MS. M. JENNINGS, AND RESOLVED THAT the « (The) Protocole d'entente amendé entre la Commission scolaire de Montréal (CSDM) (devenue le Centre de services scolaire de Montréal – CSSDM le 15 juin 2020) et la Commission scolaire English-Montréal (CSEM) relativement au partenariat entre le CSSDM et la CSEM en ce qui a trait à l'école F.A.C.E » be accepted and approved.

9. Agreement Between EMSB and CSSDM Re: Police 10 000

WHEREAS in 1998, the Commission des écoles catholiques de Montréal (CECM) was split into three new school boards, namely the Commission scolaire de Montréal (CSDM), the English Montreal School Board (EMSB) and the Commission scolaire de la Pointe-de-L'Île (CSPI);

WHEREAS in the 1998 legislative amendments, the employees of the CECM became employees of the CSDM, the EMSB or the CSPI;

WHEREAS at the time of the 1998 legislative changes, certain employees of the CECM held a life insurance policy with the *Mutual Life Insurance Company* (now *Industrial Alliance Insurance Company*), commonly known as Police 10 000;

WHEREAS in June 2020, the Commission Scolaire de Montréal became the Centre de Services scolaire de Montréal (CSSDM) and the Commission Scolaire de la Pointe-de-L'Île (CSPI) became the Centre de Services scolaire de la Pointe-de-L'Île (CSSPI);

WHEREAS the CSSDM currently acts as a policyholder of the Police 10 000 and is therefore the intermediary between *Industrial-Alliance* and the two other school boards, namely the EMSB and the CSSPI;

WHEREAS the amounts paid annually as premiums come partly from the employees as individuals (hereinafter "Employee Share") and partly from the school board/school services centre by which they are currently employed or the one that employed them at the time of their retirement (hereinafter "Employer Share");

WHEREAS following the transfer of rights and responsibilities resulting from the 1998 legislative changes, the EMSB and the CSSDM continued to collect the "Employee Share" from the employees under their respective authority and to contribute their "Employer Share" to the Police 10 000 fund;

WHEREAS during certain periods between 1998 and 2012, the EMSB did not fully remit its "Employer's Share" to the Police 10 000 insurance fund;

WHEREAS discussions were held between the CSSDM and the EMSB and they have come to an agreement in principle satisfactory for both parties;

WHEREAS the EMSB has, over the years, accrued sufficient amount of money to cover for the proposed Agreement;

IT WAS MOVED BY THE TRUSTEE, MS. M. JENNINGS, AND RESOLVED THAT the Transaction with the Centre de Services scolaire de Montréal with regard to the Police 10 000 dossier be accepted and approved.

IT WAS FURTHER RESOLVED THAT the Director General or the Assistant Directors General be authorized to sign the Transaction and all documents that may be required to give full effect to the present Resolution.

IT WAS STILL FURTHER RESOLVED THAT a copy of this Resolution be translated and sent to the Centre de Services scolaire de Montréal.

10. Special Remarks

Ms. Marlene Jennings spoke in regard to the issue of the N-word and the debate that has come up recently in the news. Ms. Jennings states it has recently come to our attention that our EMSB Secondary IV history workbooks have the N-word within them, on page 241, dealing with neo-nationalism in Quebec. She also states that the EMSB has immediately taken all necessary action to rectify this situation.

Ms. Jennings clarified some misunderstandings with regard to these textbooks and made some additional points. She also states that she is proud to be a Quebecer, she is proud that she was born and raised here and that she worked and contributed to Quebec.

- Yes, there is a Ministère de l'Éducation approved an official history textbook for secondary IV. Both an English and French version exist, that are used across the province.
- Ms. Jennings would like to make it very clear that in the official approved Secondary IV History textbook, there is no mention or use of the N-word, in either the English or French version.
- Many of the school board and school centers across the province found that the new versions either didn't deal at all with or dealt minimally with the contributions of the first nations to the building of the Quebec we know today.
- It is important to note that the revised approved version of the history textbook was found not to deal with or explain the history of our diversity in particular people of African ancestry.
- It is also important to know that the system of slavery, of trafficking humans from the continent of Africa by European countries, was actually used to build a whole economic system. This allowed many European countries to flourish, to have monies, to invent, advance science and innovation. In order to do this, those counties and societies needed to build a notion that the African people were not human, that they were property.
- The N-word in English was part of the currency of developing a justification for the human trafficking of Africans.
- Quebec was also built in part by slavery.
- A workbook was developed, which was not approved by the MEES, in order to provide a complement to the official history textbook, to provide context, to explain the actual contributions of our first nations, the actual contribution of Black Quebecer's to the building of this province.

The original workbook that was developed to complement the history textbook was written in French. When translating the word Negro, unfortunately, the N-word was used and the word went through. As soon as the EMSB became aware that this workbook was part of our curriculum, we removed the English version. We are recognizing this as a teaching moment and are looking into discussing with the publisher of this workbook placing a label over the original text. The label will include information as to why the section has been blocked out and will provide a complimentary educational lesson.

	Ms. Jennings gave special thanks to Ms. Anna Sanalitro for her great performance and accomplishment on this matter.
	Ms. Jennings read a public statement from the Quebec Board of Black Educators that she received regarding the textbook issue. She also discusses her personal ancestral history.
	Ms. Marlene Jennings also spoke to the recent court challenge against her by the incoming Council of commissioners with regard to her legal authority to the appointment of the new Director General near the end of her mandate. Ms. Jennings states that she has invited the incoming Chair to join her in the recruitment process and to join the selection committee for the appointment of the new Director General, however he has declined. Ms. Jennings advises that she issued another invitation last week, also sharing the documents and progress report from the Executive Head Hunter firm, Mandrake. In the documentation sent, the identity of all the candidates was removed as under the best practice guidelines the identity of individuals who have applied for positions must be kept confidential to the public unless you are part of the selection and recommendation committee. She states that the incoming Chair has again declined. Ms. Jennings wants to make it clear that at no time did anyone call into question the rigorous process of the selection committee. Ms. Jennings points out that she has all the confidence in the selection committee. She is positive that when they start the interview process, the selection committee will explore with the candidates their involvement, knowledge, and advocacy for the English minority language communities; the role and the importance of the advocacy that the EMSB has historically undertaken, and will continue to take on protecting our constitutional right under section 23 of the Canadian Charter of rights and freedoms.
