### 1. Welcome

Mr. Benny Berneti thanked Mr. Luigi Garofalo for taking the last Governing Board minutes. He also welcomed Ms. Angela Antonacci as the Acting Vice Principal replacing Ms. Patrizia Tummillo.

### 4. New Business

### 4.1 Uniform Update

The requirement for students to wear the school uniform was implemented at the beginning of December and it has been going very well. Approximately 100 students were given special passes since they were still missing a part of the uniform. A sub-committee will be meeting in January/February 2019 and sending a letter to the school board indicating the problems encountered and attempt setting up a meeting with other schools to discuss the issues experienced with the same company.

## 4.2 Sexual Education Program presentation & approval

Commencing in January/February 2019 teachers will apply the sexual education program as part of their classes which would be approximately 10/hrs per grade. Ms. Lisa Triestino has been working with a school board consultant and teachers will get the necessary training. The program will discuss topics such as having healthy relations. Teachers will be comfortable in presenting this program. Parents can opt out of a specific topic if they feel it goes against their human rights or if a student was a victim of sexual violence. There is a process to follow if a parent/student wants to opt out. As a school, we should be open and be able to talk about the program. Ms. Clorinda Antonacci moved to adopt the program. Mr. Pierre Labrecque seconded the motion. All were in favor.

## 4.3 Educational Project Plan

The educational project plan will replace the MESA. The school board has specified certain targets they would like to achieve. It's part of the school board's success plan. The process involves discussing the challenges the school faces and obtaining feedback from the community at our next governing board meeting scheduled for January 22, 2019. The educational project plan will need to be approved by April 15, 2019.

## 4.4 French EST course next year

Environmental Science in French – After careful analysis, Mr. Vitantonio mentioned that this course will not be possible due to lack of resources such as: teacher allocation. This course will result in extra group(s) with very little beneficial impact. The students are already practicing French example: regular French. Therefore, the cost of implementing the course outweighs the benefits.
