Announced the welcome back corn roast; Pizza lunch is back full swing; Teacher appreciation week coming up; Need new volunteers.

8. Teachers' reports

Kathleen Laranjeiro and Jinan Paquin reported for Grades 5-6, said things are cool; discussed things such as the Caribou Math competition.

Diane Biard-Goble mentioned students would be participating in a Quebec writing project through Blue Metropolis; theme is "fear and loneliness".

Grade 4s are doing Gardening workshops.

Julie Marcus gave a Grades 1/2 English report — phonics, debates, reading/writing and so on.

9: Principal and Vice Principal report

9.1 School profile

Principal Joanna Genovezos declared Roslyn "post-Covid"; says all teachers are here, the school is fully staffed; Enrolment is 560; with coded students it counts as 670; All coded students have resources/behavioural techs and other supports. 130 students on IEPs; 73 of these are non-coded; 53 students are officially coded. Roslyn is the third largest school in EMSB.

Joanna Genovezos ran through the rest of the numbers — teachers, classes, and so on.

Resource teacher Stephanie lanelli explained what she's up to.

From Joanna Genovezos: More general discussion about the education plan and the school safety plan; the beautification plan and the need for parent donations.

There was general discussion around coding, assessments, funding.

Joanna Genovezos presented the Respect campaign from the EMSB.

Ends by saying she wants to see Roslyn thrive as it was before COVID; parents with a deep involvement in the school.

Vice Principal Mireille Tehbelian noted that on Sept 8-9 they held the first in-school assembly; the theme was values and the school motto (work hard, play fair, be kind); She said the school will hold one assembly a month throughout the school year

High school road shows took place during the month of September, where EMSB high schools come to Roslyn; This includes Westmount HS and Marymount.

Youth Theatre Canada came on Sept 12 and some students voluntarily participated for auditions. Call backs will be done by Youth Theatre Canada for selected students.

Parent workshop on Sept 22; package will be distributed to the community.

She then listed further details of activities at the school.

The first fire drill of the school year took place on Sept. 28th.

9.2 Enrichment

Mireille Tehbelian said she had met with Ms. Camelia Birleanabout the enrichment program; Beginning with Caribou Math on Oct. 19th (Gr 3-6) This activity will be held once a month from October until May 2023; Other enrichment activities are to begin

later in the school year such as English Language Arts (debating and public speaking for grades 4-6, Battle of the Books and a science program for grade 6).

10.1 Vote in re-adoption of funds left over.
