### 6.1. Principal's Report

- CAQ took \$31M from EMSB, small funds are released to schools and schools must justify what they spent it on to the ministry. As a result, special needs support staff are stretched. Less lunch monitors so Junior and Senior

students are all in one yard for recess. They spend lunch in both the junior (K4 to Grade 2) and senior (Grades 3 to 6) school yard

- 2 ways to fundraise: 1) Canada Helps page for the school 2) PPO can raise funds within the community
- Grad Car wash was a great success. More fundraisers to come to compensate for budget cuts.
- PPO Pizza fundraiser was a hit! Looking forward to the next one
- AGA great turn-out! 19 parents showed interest in signing up for the PPO.
- New staff: Shayna Lavoie was secured to replace in Cycle II (Grade 3 & Grade 4) French
- Need new daycare tech, missing one CCW
- Operation Warmth contacted us last year to provide winter clothes for our school.
- Cycle 2 and 3 students: Les Scientifique program - two cohorts of 12 (24 students in total) selected to work with animators once a week to work on fun science (i.e. dinos, kaleidoscopes, etc...) in French. Cohort will end Dec 16 but advanced cohort will be selected for January.
